The Gloucester County Planning Commission will hold a Public Hearing in the Colonial Courthouse, located at 6504 Main Street, Gloucester, Virginia on Thursday, July 11, 2024 beginning at 6:30 PM to consider the following:

REVISIONS AND UPDATES TO THE GLOUCESTER COUNTY ZONING ORDINANCE

Pursuant to Virginia Code § 15.2-2204, 15.2-2285, and 15.2-1433, the Planning Commission gives notice of its intent to hold a public hearing on the Zoning Ordinance Update. The proposed revisions and updates to the Gloucester County Zoning Ordinance include revisions to the types of permitted uses in each district and processes for approval, definitions, district regulations, supplemental use regulations, nonconformities, sign and parking requirements, administrative procedures, and enforcement, among other components. The proposed changes do not include any rezonings or changes to the minimum lot sizes for single family homes. A map of the County's zoning districts in their current state, as depicted in the County's geographic information system, is proposed to be adopted as the official Gloucester County Zoning Map.

Comments submitted through these methods must be received by 4:30 PM on July 11, 2024 and will be read or played during the public hearing up to the time limit set by the Chair.

"Form letters," consisting of communications which are verbatim duplicates (other than the identifying information of the author/submitter) of one or more other communications received by the County pertaining to the matter to be considered at the public hearing or public comment period, shall be read only once per letter, along with the list of persons submitting the same comments pursuant to such "form letter."
